

## **Section 10: No Longer Asleep at the Wheel – The American Government’s Resurgence**

As we Americans awaken from our slumber, it is becoming clearer every day that the U.S. Government and its State Government franchises with their divisive, two-party system in Washington, DC., and layer after layer of subcontractors and NGOs, are the main current, criminal rackets that are blazing a path of mayhem all over the Earth. They seek to widen their profit margins and maintain full control over America. They believe that if they keep Americans believing the lies, they will be successful. Not anymore. We see and we do not consent.

We have the receipts.

We have proved our provenance establishing on record that the verified, Head of State, of our country, America, is James Clinton Belcher, who holds the official seals of our country through his lineage.

We have proved our standing establishing on record that the verified claim in all international jurisdictions, air, land and sea, to all of America’s assets are held by our Fiduciary, Anna von Riezinger, being unrefuted by all other claimants.

We have proved our nationality as American establishing on record that a crime of unlawful conversion of our political status into both British and Roman Citizen had occurred without our knowledge or consent.

We have proved on the record all claims of “interregnum” were unfounded being based on criminal impersonation and usurpation of our American Federal government subcontractors, our States of America corporation and its Federal Republic franchise corporations by the British President of the United States of America, Incorporated, Abraham Lincoln. This crime has been established as unrebutted fact on the public record to have been committed by our hired hands in collusion, our British Federal government subcontractors and our Roman Federal government subcontractors.

We have proved on the record that The United States of America holding company established on July 4, 1776 by The Unanimous Declaration of Independence, has been maintained since 1776 to the present.

The hereditary Head of State has identified and verified one man in each State who possesses the hereditary lineage as an American dating back prior to 1860 as is required that enabled him to restore the legitimate Civil government of America.

After presenting all of these receipts to the Admirals and Commander-in-Chief of the British U.S. Military who still has America under military occupation since Abraham Lincoln, they refuse to recognize us and continue on with their **criminal impersonation schemes** claiming to be us in the face of the American public and to the world leaders.

The American government as the Employers and the U.S. Government as our Employees are both responsible for the misadministration and overreach of government in America today. We admit this and have taken the necessary steps to correct the public record and restore the function of the **American Civil government**.

So, what happens next?

## The Buck Stops Here

Let me reiterate these facts of American History that our public schools will not teach to you because the schools are commandeered by our U.S. British Territorial and Roman Municipal government services subcontractors and their franchises who want to prevent the American public from knowing who they (the Federal Subcontractors) really are.

When referring to our combined States' national soil jurisdiction, we operate as: The United States.

And when you are referring to the combined States' international jurisdictions we operate as: The United States of America.

Neither one of these unincorporated **Public entities** have ever been bankrupt, and indeed, neither are eligible for bankruptcy protection. Both enjoy state immunity, instead.

Neither one, The United States nor The United States of America, have ever participated in any form of **insurance scheme**. Both are **indemnified**, instead.

We are your American Government. We hired the "U.S. Government" under signed contracts to provide America with essential governmental services which have been paid for since 1941. You all know these agreements as the "Constitution." Remember, there were three (3) of them not one (1) because there were three (3) federal Subcontractors originally.

We refer to our employees as our Federal Subcontractors. The phrase "U.S. Government" has become an idiom. It makes it easier to address them but it has caused grave confusion. Our Federal Subcontractors are for-profit corporations and in reality, cannot by definition be an actual "government."

Their officers hold private corporate offices and cannot hold the Public Offices owed to the American people, simply because they are private foreign citizens and they are not American.

They have a history of committing criminal bankruptcy fraud.

The first cyclical double bankruptcy fraud happened in 1863 and 1868. The next round happened in 1907 and 1921. The next round was in 1925 and 1930. (A separate domestic bankruptcy was also declared in 1933.) And we've just gone through another iteration in 2008 and 2015.

Remember, the Holy See got into the act and joined the British fraud scheme in the 1920's, and so, got its share of the take by fronting one of the perpetually bankrupt look-alike, sound-alike corporations as a Municipal CORPORATION.

It's all criminal and it's all fraud, but each time they pulled this little trick, they offloaded their corporate debts onto the backs of the clueless Americans.

They did this by pretending that these same Americans were voluntarily acting as "named franchises" of these same bankrupt corporations, subject to paying off the parent corporation's debts.

As of March 13th 2022, the **second bankruptcy** in the series concluded, and The Office of the Fiduciary of The United States of America, the actual Federation of States, which is the Priority Creditor, has nationalized all the various bankrupt corporations, franchises, and derivatives as of March 24th 2022.

What does that mean? It means that the Priority Creditor exercised their option to take over control of all these **bankrupt corporations**, their franchises, and derivatives (like the Public Transmitting Utilities bearing names like "Walter T Fussbottom) and has placed them under Public Law.

Additionally, the Priority Creditor has exercised the option to take control of the Federal Reserve Note, an illegal domestic fiat currency of the Debtors/DEBTORS, which has been foisted off on everyone as an international currency.

This was done to put a halt to various crimes, including involuntary enslavement and peonage, the misrepresentation of Creditors as Debtors, **identity theft fraud**, counterfeiting, unlawful conversion of assets, false claims on abandonment, evasion of constitutional obligations, bank fraud, international conspiracy to defraud, and other evils.

As of October 1, 2024, the Municipal Federal Subcontractor was finally bankrupted and no longer exist. Yet, the British Federal Subcontractor still exists. Remember, the American Federal Subcontractor ceased to exist in 1861 and was not reconstructed. That's the accounting of our three (3) Federal Subcontractors and the status of their three (3) constitutional agreements. Also, remember that these foreign, federal corporations are really Subcontractors of Subcontractors.

There is only one form of American Government operating in international jurisdiction, and that is the original unincorporated American Federation of States doing business as The United States of America. The so-called "Federal Agencies" and so on, are just private subcontractors wondering where their next meal comes from.

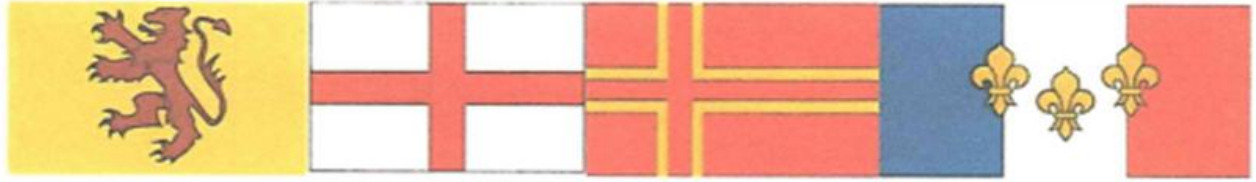

## We Are at Peace

Please note that **President Andrew Jackson** three times publicly declared the Continental United States to be at peace. He admitted that the land jurisdiction is at peace and it has been at peace for **150 years**. We raised our **Civil Peacetime Flag, Open Gate**, on October 21, 2017. # International Peace Proclamation and Grand Peace Treaty

## International Peace Proclamation

Be it known to All to Whom these Presents come: an International Peace Treaty has been established ending all hostilities related to The American Civil War which unofficially began in 1861 with an Executive Declaration issued by then-Territorial President Abraham Lincoln.

## Grand Peace Treaty of the States

Insomuch as a mercenary conflict known as The American Civil War was engendered and fought by members of the Confederation of States existing in 1860, and that conflict has been left unresolved, now let it be agreed and declared that this Grand Peace Treaty of the States has been approved by the Owner States and has been established and bound upon these Several Parties by mutual Treaty Agreement among these and among the Several States now existing, and also applies to all Subcontractors and Employees exercising Delegated Powers:

**Agreement 1:** That all States and all Confederate States now or in future existing agree to an immediate and permanent cessation of hostilities connected in any way to The American Civil War;

**Agreement 2:** This cessation of hostilities and resulting peace extends on the soil, in the air, on the land, and at sea, and is also an obligation of all those exercising delegated powers on behalf of our States;

**Agreement 3:** All the States then-existing and existing now, have abolished by Roll Call Vote all forms of slavery and peonage within their borders, within their Territories and Possessions, and within the realm of their intellectual properties, so that no more legal presumptions, exclusions, or suppositions may be used to evade the paramount provisions of our Organic and Public Laws;

**Agreement 4:** All the States then-existing and existing now, agree via this Grand Peace Treaty of the States to uphold this peace both within and without their borders and to forever end and release the disputes arising from The American Civil War, and to return all States to their natural status and sovereignty as States of the Union without exception and according to the Equal Footing Doctrine;

**Agreement 5:** All States now existing agree that the votes of all State Members of the unincorporated Federation of States doing business as The United States of America are now and have remained valid without exception before, during, and after The American Civil War.



## International Peace Proclamation

To all whom these presents come: this Proclamation provides explicit and official International Notice that Peace has been Declared by and among the Union States of the States of America and Federation States of the Union, in receipt of the authorities of the former Confederate States, in the matter of The American Civil War. All jurisdictions and instrumentalities must comply. All Federal, Territorial, and Municipal Officers, including all Uniformed Officers, must comply.

It is required that all hostilities related to The American Civil War being conducted as a Mercenary Conflict in International and Global Jurisdictions and having been maintained for 156 years by our foreign Subcontractors, must cease and desist without further Legal Presumption of Authority.

With this Public Announcement all Executive Orders issued during and as a result of The American Civil War are set aside effective at midnight the first of August in the year of 2021.

All Medical Officers and all General Staff and Reserve and Retired elements of the American Armed Forces, U.S. Armed Forces, UNITED STATES ARMED FORCES, US ARMED FORCES, Hospital Corps, MEDICAL UNITS, Veterans Administration, United States Department of Defense, UN Peacekeepers, DOD Officers, NATO Officers on shore, all elected, appointed, or promoted personnel and their dependents, are required to cease and desist all gene therapy extinction protocols, coerced injections, mask mandates, and similar measures being promoted by the Territorial and Municipal United States Governments in Breach of Trust and under False Presumptions of War. All peacekeeping officers and police officers are fully informed.

The Project is a 6-Phase grassroots, Nationwide Outreach Project of which the mission is to restore the Sovereign Governance of America --- of the people, by the people and for the people --- in commitment to our **founding document**, The Unanimous Declaration of Independence of 1776.

The following are The Project's objectives:

1. "Go Public" as The Federation of States of "50-in-full-force," (a slogan coined for this project to capture the sentiment of our end resolve), and take our place on the world stage as the rightful **sovereign American Government**.
2. Rescue every American from sea and air jurisdictions and bring them back home to the land and soil jurisdictions by placing their Declarations of Political Status on the public record while educating them along the way.
3. Demand the **capitulation** of our Territorial and Municipal United States Government Subcontractors to transfer the governance of America back into the control of the Sovereign American Government in full recognition as their Employers.

7. Keep the Territorial and Municipal United States **Government Subcontractors** in place and require them to continue to provide services with **zero-sum transactions** or they pay the expenses out of their own coffers not ours, until and unless, they peacefully transfer America's governance back into the hands of Americans.

8. Lawfully end the revolving door of criminal bankruptcy fraud and commercial fraud of corporations on our land and soil via our special **concurrent General Jurisdiction** over all LAW capacity.
9. Convene a Continental Congress to review the Constitutions, i.e. Contracts, for the consideration of termination or renegotiation and to decide on new leadership involving the election of “The” President of “The” United States of America and/or appointing a Head of State successor.
