

## Section 12: No Longer Asleep at the Wheel – Remedies: Real Life Examples

Here is a list of remedies that have been implemented by American state nationals. These remedies are provided as anecdotal evidence in hopes to inspire you to create your own remedies for your specific situations. Americans are owed our Constitutional guarantees. However, every American has a duty to enforce them when they are not being honored.

### “There Has Been a Mistake” Letter to the Court

**Example 1:** Here is a Response Letter by an American State National on Ohio when he received an offer to contract from a STATE OF OHIO Municipal Court to inform them **“There has been a mistake”** --- a case of mistaken identity.

There has been a mistake.

I am a private American State National. I am not in CUYAHOGA FALLS, OHIO jurisdiction and do not acquiesce to it. As such, I am not to be addressed by you or your office/OFFICE.

I do not wish to contract with either of you. This is in response to the letter using my private name sent to me from your office/OFFICE. I have included a copy as a reminder.

As per my recorded Deed of Re-conveyance, I have re-conveyed that name back to the Land and Soil Jurisdiction of Ohio. I am the sole living owner, executor, beneficiary and agent of my name and estate since my 21st birthday.

As per my recorded Certificate of Assumed Name, I have reclaimed, copyrighted, and permanently domiciled my name on the land and soil of Ohio, together with all styles, orders, forms, punctuation, variation, abbreviations, and other derivatives. My private name is not to be used by you or your office/OFFICE.

I have recorded my Foreign Sovereign Immunity Notice to rebut any presumption that I am a Territorial Citizen.

I have recorded my Declaration of Political Status and gave notice of my Declaration of Political status to ANTONY BLINKIN, U.S. SECRETARY OF STATE to rebut any presumption that I am a Municipal Citizen.

Please do not contact me again. If you or your office/OFFICE do, I will submit an invoice to both of you, which will be due within 15 days of receipt, as per my recorded Fee Schedule.

All paperwork declaring my status as a private American, placing me outside of CUYAHOGA FALLS, OHIO jurisdiction, including my Deed of Re-Conveyance, Certificate of Assumed Name, Mandatory Notice, Declaration of Political Status, and Fee Schedule have been placed on the public record.

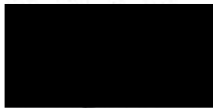
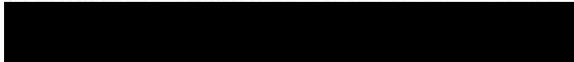

## Revocation of Election – Stop All Payroll Withholdings

**Example 2:** Here is a **Notice of Revocation of Election** by an American State National to her employer requiring her employer to stop all payroll deductions from her paycheck --- federal, state and local income tax and social security and Medicare tax.

### **Notice of Revocation of Election for Voluntary Tax Withholdings with Updated W4 and Ohio IT4**

I am providing this documentary evidence to become part of my record. This documentation shall remain alongside and as a part of my attached updated W-4 and Ohio IT4.

**NOTICE:** I have corrected my political status so that I am clearly an American and exempt by nature and without incorporated United States (U.S./US/District of Columbia) citizenship, resident, taxpayer, employment and/or contract obligations.

[bold added for emphasis to note this section is missing in the opening paragraph of the OH IT4 form instructions]

 The term “taxpayer” means any person subject to any internal revenue tax

4. Internal Revenue Manual 5.14.10.2 (09-30-2004): Payroll Deduction Agreements  
 2. **Private employers, states, and political subdivisions are not required to enter into payroll deduction agreements. Taxpayers** should determine whether their employers will accept and process executed agreements before agreements are submitted for approval and finalized. [bold added for emphasis to note payroll deductions are voluntary agreements initiated by the taxpayer]
  
5. “The revenue laws are a code or system in regulation of tax assessment and collection. They relate to taxpayers and not to nontaxpayers. The latter are without our scope. No procedure is prescribed for nontaxpayers, and no attempt is made to annul any of their rights and remedies in due course of law. With them [nontaxpayers] Congress does not assume to deal, and they are neither of the subject nor of the object of revenue laws.” Long v Rasmussen, 281 F. 236 (DC Montana 1922), also see Economy Plumbing and Heating Co. v United States 470 F.2d 585 (1972), Pollock v. Farmers's Loan and Trust Co. (1895) (bold added for emphasis to note Congress revenue laws do not apply to nontaxpayers at all)

**I hereby affirm that:**

1. I am an Ohioan, a State National, as per 8 U.S.C. 1101(a)(21). (See attached United States of America Passport, Birth Certificate and American State National Credentials card)
  
2. I am not a Territorial United States citizen, MUNICIPAL CITIZEN of the United States, franchisee, taxpayer, resident, person, individual or any other legal fiction, nor have I ever been knowingly and/or willingly.
  
3. I have properly notified the U.S. Secretary of State by registered mail # RB659982680US of my declaration of political status as an Illinoisan and I have claimed my exemptions per 8 U.S.C. 1101(a)(21). (See attached Letter)
  
4. I have properly notified IRS leadership of my revocation of my election to pay federal income taxes; notification sent to both the Commissioner of the IRS (New York) and Internal Revenue, Office of the Commissioner (Washington D.C.) by registered mail #RB659982716US and #RB659982693US, respectively. 26 CFR 1.1871-1(a), 26 U.S.C. 6013(g)(4)(A) (See attached Letters)
  
5. I have properly notified the local taxing agency, Regional Income Tax Agency, and state taxing agency, Ohio Department of Taxation, of my declaration of political status as an Ohio state Citizen/National, exempt from their Territorial and MUNICIPAL incorporated jurisdictions. I reserved my right to NOT contract as a taxpayer and ordered to cease and desist communications. (See attached Letter)
  
6. I do not consent nor do I volunteer to be a taxpayer and have revoked all signatures to any and all

commercial agreements to pay taxes.

- 7. I have recorded all documentation of political status and exemptions on the public record, Publishing #: 2022-iS9d-SpQL. (To view, scan QR code or follow link on back of attached American State National Credentials card.)

I hereby provide written revocation of election for voluntary tax withholdings to include federal, state and local income, medicare and social security taxes and affirm my "non-taxable" and "nontaxpayer" status; thereby not subject to ANY internal revenue tax. (See attached Notice of Revocation, Cancellation, Annulment, Rescission and Extinguishment of all prior signatures, Digital Certificates, Easements, Licenses and Power(s) of Attorney)

Based on my exempt status having revoked all taxpayer contracts and herein affirmed my "non-U.S. citizen/resident" political status, ie. State National, I require that no withholdings of any amounts be deducted from my earnings per attached updated W-4 and Ohio IT4 which I am submitting for information purposes ONLY, effective immediately.

## Notice of Individual Master File Error to IRS

Example 3: After sending her Notice of Revocation of Election to pay taxes to the IRS and got constant letters of delay from the IRS, an American State National submitted a Freedom of Information Act (FOIA) request to find out if "Revocation of Election" was attached to her IRS account. The FOIA records showed "**Frivolous** Return Program" status attached to her Notice in her IRS Master File. Thus, her Notice in reply to the IRS based on these FOIA finding follows below. Note: She never received that Letter 3175C.

Re: Alleged Unlawful Exercise of Rights

Dear Ms. Campbell-Anthony:

On June 26, 2023, the Office of the Governor received several documents from you dated June 9, 2023. Some of the documents cite to various federal laws, including: a Declaration of Political Status, Declaration of Nationalization Act of 1779, Certificate of Assumed Names, Mandatory Notice – Foreign Sovereign Immunities Act, Notice of Intent – Fee Schedule, and other miscellaneous legal citations. The Cover Letter states: “Notice and Declaration Regarding Unlawful Exercise of Right of Distrainment or Levy” and lists various federal and State officials as receipt.

We explicitly reject the legitimacy of these documents and any claims they have been, or attempted to, be asserted. You are now on notice that, under Ohio Revised Code 2921.52(B), no person shall knowingly display, deliver, distribute, or otherwise use a sham legal process or knowingly use a sham legal process to arrest, detain, search, or seize any person or the property of another person.

Our Office does not accept service of these letters as such communication does not meet the State of Ohio’s legal requirements for notice. As such, our receipt of the documents and subsequent communication does not imply that the contents of the documents are correct, nor that our Office agrees to or is bound by any claims asserted therein.

Dear Matthew:

i, a woman: Louise Campbell-Anthony received your rebuttal dated August 14, 2023. i, am thrilled that you acknowledge receipt of my lawful documents. i, am concerned that you have not received the proper training and education regarding the lawful jurisdiction of the Land and Soil. i, am a living woman and not a legal fiction nor do i, accept any titles of nobility as exemplified in your rebuttal addressing i, as Ms./Mrs./Miss/Ma'am.

Your rejection of the legitimacy of my lawful documents is an obvious lack of knowledge in the body of Supreme Court decisions regarding the separation of lawful and legal jurisdictions. i, comprehend that your legal jurisdiction would like to believe that the lawful jurisdiction is in interregnum. Rejecting or denying the existence of other jurisdictions of law does not make it so. Ohio Revised Code, in its entirety, only applies to the legal fictions, and federal employees/Federal Employees/ FEDERAL EMPLOYEES. i, am not a federal employee/Federal Employee/ FEDERAL EMPLOYEE. The Declaration of the Naturalization Act of 1779, still an active Act of our first Continental Congress, stands as remedy to any presumptions of legal fiction or subject to presumed indenturement. Unlawful conversion is a high crime and only a man or woman may declare their political status. Legal process when applied to a living wo/man is a sham and obfuscation of the Public Law (Title 18 § 241 and 242). Also, for your review, i, advise 3C Am Jur 2d §273.

All requirements of your legal procedures and policies regarding notices, do not apply to a lawful wo/man. Although The Notice and Declaration Regarding Unlawful Exercise of Right and Distraint or Levy, enclosed, does meet your legal requirements, this was merely a courtesy. All elements of a proper notice listed below were met:
