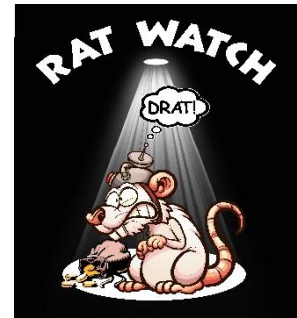


## Section 13: No Longer Asleep at the Wheel – Sir, You Are out of Your Jurisdiction





It is essential, now that we know what has happened, that Americans stay on high alert watch for these rats to prevent our government from being usurped ever again.













Each American State and County Assembly is that governing unincorporated body politic of living people, who have stepped up to serve in your government to protect all of our rights and assets.

The **soil jurisdiction** is the fourth jurisdiction and it is national in nature. It is not included in the Global Estate Trust.
