

Section 4: The Fraud Perpetrated upon America – Their Criminal Fraud Schemes Continues Today

This dualism is being set up on purpose and exploited to keep people in a constant state of "war"--- because the parasites gain power and money from it. No other reason.

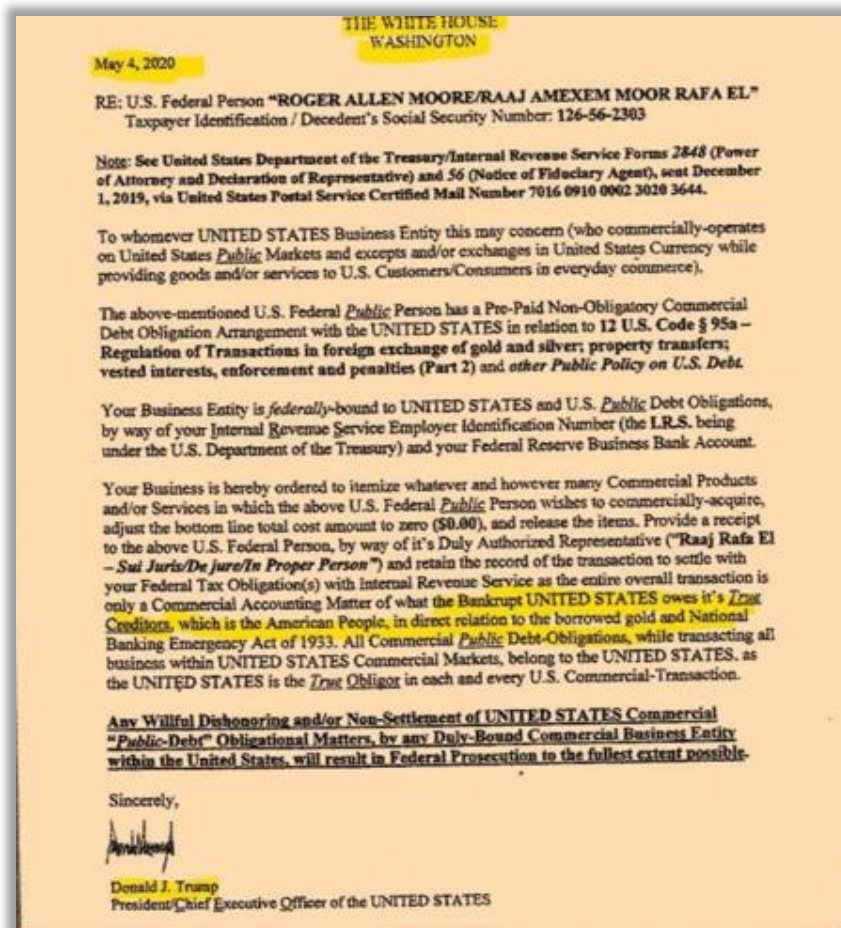
Elections

Wars

“Wars” are just commercial mercenary conflicts as was the Civil War and every single “war” since. Actual wars end in Treaties among sovereign nations. 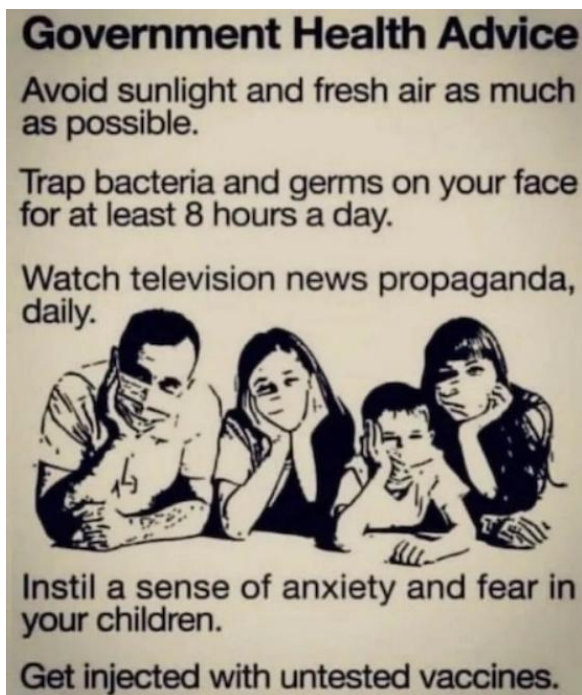
It's not pretty. It's not patriotic. It's true.

Since the days of Lincoln, our military are bonafide, paid mercenaries carrying out the orders of criminal corporations pawning themselves off as our American government. 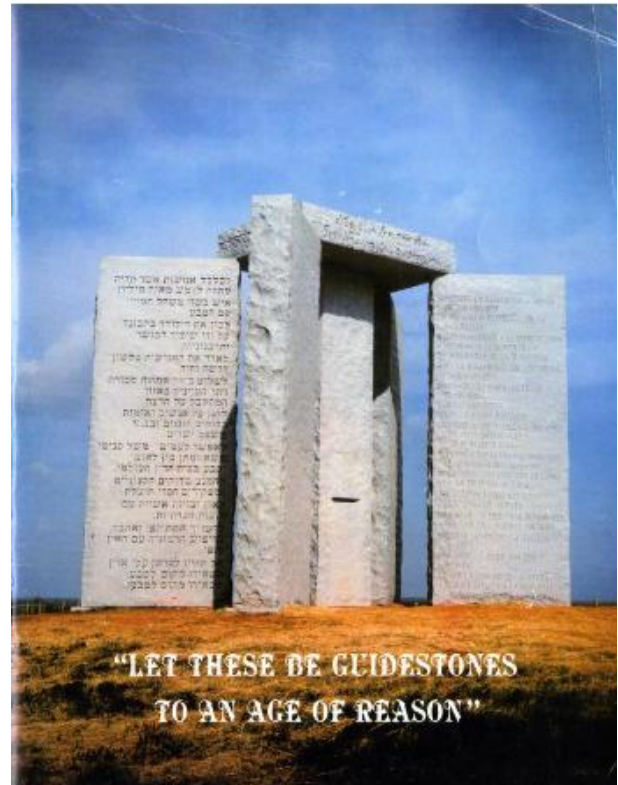
Religion

The fraud, my dears, goes back to the Founding with the first President of the **United States corporation**.

Public Private Partnerships

Public Private Partnerships are used as shields to infringe upon the **Bill of Rights**, meaning the unalienable rights that are owed to every American, as well as to infringe upon the civil rights and the human rights that have been granted by government services corporations to their citizenry. The quasi-government corporations and subsidiaries act as the fall guy so their parent government service corporations, i.e. the United States of America British Territorial “government” and the United States Roman Municipal “government,” can claim plausible deniability. For instance, Facebook, Google and CNN are DOD/CIA initiated media, **surveillance**, **propaganda** and **censorship** systems that are paid for under the table and behind our backs to do the bidding of Big Corp. and, in some cases, are even their brainchild as in the case of Facebook.

Franchising

The incorporated, U.S. government franchises operating as States of State subsidiaries operating in every State of the Union pawn themselves off as “The” American State of State franchise organizations when they are not. These are incorporated franchises of the United States parent corporation in the business of taxing and harming the people to make money and diminish our lives. No, your state’s infrastructure is not paid by your tax dollars, it was paid long time ago by the public trust that made taxing unnecessary. The initial **block grants** given to the States by the U.S. Government corporation initiated them into this fraudulent substitution scheme with the exception of Texas. The only state that has sustained their Republic throughout all of this.

Central Banks

The **Central Banking** system are the cartels who provide the funding to the newly-formed United States shell corporations after bankruptcy. These corporations are reorganized by the same criminal officers of the old bankrupted, United States corporations who claimed the assets of the Americans as their collateral. All the while, these corporations have not presented the banks with a valid contract to **underwrite** any of these claims made by these government corporations. The United States shell corporations need startup capital to exist and who do they have in their back pocket to make it happen...the **commercial banks**. If you didn’t know, banks don’t have any money of their own to lend anyone. So how are they even funded?by the corrupt Central Bank **cartels** who are benefitting from the racketeering scheme.

The purpose of all Central Banks is **commodity rigging (Wall Street)**. Thanks to the **Central Banking System** none of the other banks can make money out of thin air; they have to borrow it from the **Central Bank** and pay interest for the privilege— a cost which they pass on to their customers.

Commercial banks deal in what is called "commercial paper" --- which creates representations of accounts, filled with "money of account" ---which is credit, not actual money.

Mortgages, securities, stocks, bonds, promissory notes, letters of credit, bank drafts, checks, court judgments, debits, liens, and so on are examples of commercial paper instruments.

The process by which the Central Banks bilked the public and the commercial banks into giving control to them is a story in itself, but the transition from the necessity of minting gold coins to printing gold and silver certificates was followed by a transition of printing promissory notes to replace the gold and silver certificates and from there it was a short step to issue "digital tokens" — mere keystrokes on a **digital ledger**, to represent anything the Central Bank wants to represent. Now, they propose to sell you not only **Monopoly Money**, but Monopoly Money that can be created or erased by a keystroke in an imaginary "digital wallet", and of course, they will have absolute control over who has access to these precious keystrokes, who is rich in keystrokes and who is poor, who gets to buy things using "their" keystrokes and who is cut out of "their" market and left to starve. We must now either wake up or go mad, and be enslaved by our delusions.

Human Trafficking

Human trafficking occurs on many different levels of society, both in the physical and on paper, and many people are unable or unwilling to acknowledge and address the issue. Immigrants are being trafficked across the **borders (crisis)** into America; commercial bonds (**birth certificate bonds**) are taken out on every child born and registered via a birth certificate; pedophilia rings operate in and out of the Roman Catholic church; child sex trafficking rings such as with **Jeffrey Epstein** and Pizzagate exists among the elite; State child protective services agencies and black budget military operations are smuggling sex slaves, etc. There are too many ways to mention. And for what? Adrenochrome harvesting for ritual sacrifices among the elite and Secret Societies is in high demand. Sex and slavery have always been cash cows obtained through unsuspecting, creative avenues. As you review these forms of human trafficking, ask yourself, who funds these activities?

Philanthropy

No, it's not out of the goodness of their own heart. Government corporations do not really care about justice and fairness for people, but **social engineering** is the real goal. If you think logically and logistically about the fact that every movement and every protest had to have financial backing (ie. **Black Lives Matter Movement, Transgender Movement, Civil Rights Movement**). Now we are getting back into the realms of commercial banking. Identify the corporations that are funding the protest or movement and you will find the foreign government services corporations, its quasi-corporations, subsidiaries or public-private partnership companies funding the fuel to fan the flames of the divisiveness they are engineering.

National Emergencies

When **National emergencies** are declared, you can bet that a false flag is afoot and will be used to usher in martial law. The government service corporations are attempting to seize someone's or some country's property, lots of it, or to kill some group(s) of people, lots of them. (See False Flags above.)

National Security

The Perpetrators openly admit that all of this has been done under a "**Cloak of Secrecy**" for "**National Security Reasons**" --- and they simply neglect to mention which nation's security would be at risk as a result of full and honest disclosure of the circumstance and the breach of trust and the service contracts involved. America would not be at risk. Their US Government corporation would be. Interlocking Directorates

*"What are **Interlocking Directorates**? In simple terms, board directors who accept positions on the boards of two or more companies are called interlocking directorates. Interlocking directorates are usually undesirable for both companies and the director because it can complicate board members' fiduciary duties. Board members must act as a prudent person would and work in the company's best interest. But that's easier said than done when a board member's loyalties are divided." diligent.com*

Not only is it undesirable but criminal according to their copyrighted statute at **15 U.S.C. § 19**. You will need to see the United States federal government and state government franchises as they really are – being incorporated business entities – and it will become fathomable how this is happening right in front of your faces.
