

Section 9: No Longer Asleep at the Wheel – Restoration Timeline



James Clinton Belcher
Hereditary Head of State
of The United States of America, the
unincorporated Federation of States

James Clinton Belcher is the lawfully married husband of Anna von Rietzinger. The Belchers aren't a family. They're a very large French clan, similar to the Clans in Scotland and Ireland. They are the people of Northern and Western France, and the head of the Clan is called "**The Belle Cher**", in exactly the same way that the head of the Clan McDonald is still called "The MacDonald".

The Great Seals of both the United States and the United States of America are part of their armorial array and belong to them; every ship that has ever sailed under their seals also sails under their flag, which they provided to this fledgling country, and **vouchsafed** to it for its use and its prosperity forevermore so long as it adheres to The Declaration of Independence. Just look at the Great Seals and look at their **Coat of Arms**.

Our claims to our individual sovereignty go back to the Dark Ages and in more recent times, with respect to any claims by England, to **William the Conqueror**.

Head of State of The United States of America, est. 1776

The Belchers were among those who received "sovereignty in their own right" as part of The **Norman Settlement** upon William's death. They have been free men and "sovereigns in their own right" in England ever since, and just as William gave them this gift upon his death, they bequeathed the same upon all the soldiers in the **Continental Army** and upon all those who are born on the soil of this country.

This is how the people of this country became recognized as "sovereigns in their own right" even within the European system of Monarchy, and this is how the head of the Belchers became the Head of State -- though in fact he is sovereign in exactly the same way as any other American.

It's his Clan's Coat of Arms that was adopted to create the Great Seals; the Great Seals and flags attached to them have been donated via trust to this country and are held in trust by the Donors and the Beneficiaries. As the chief Donor, James became Head of State in International Jurisdiction and **Post Master** of the land; he's the one who has standing to enforce The Declaration of Independence against Britain and all Treaties with the British Monarch, Holy See, and **Lord Mayor of London** as an Equal Principal.

What did you think the Great Seals were? And who did you think issued them?

And why do you think they exist? What do you think they are used for? Under what authority was your Navy and Armed Forces and your merchant fleet and Post Office and Seat of Government recognized by the rest of the world?

During the Theodore Roosevelt Administration the Scottish Interloper doing business as “The United States of America, Inc.” founded in 1868, was preparing to go bankrupt, James’ Great-Uncle, **Clintwood Belcher**, rode to Washington, DC, to take possession of the Great Seals — The Great Seal of the United States of America and The Great Seal of the United States.

On his way home, as he crossed over into Maryland, he was viciously attacked by men waiting to ambush him. In the resulting fight, he killed six of his attackers. His own horse was killed also.

He grabbed one of the dead men’s horses and rode off into the night, making for the western Frontier to save his life.

They stole the Great Seals and they lied about the whole circumstance and branded Clintwood Belcher as a “horse thief” — neatly omitting their own grand theft under deadly force, their intent to murder, their killing of his horse, and all the rest of it. He spent the rest of his life “on the lam”, always looking over his shoulder, always moving from place to place to place.

Theodore Roosevelt considered him “a danger to our government” — self-evidently meaning the foreign Territorial usurpers on our shores.

Clintwood died without issue, so the torch passed to his younger brother, James, and from James to his son Orville, and from Orville to his son, James Clinton Belcher. At the time James was born in 1941, Federal Agents were still hunting and harassing members of the family.

Orville Belcher moved his young son twelve times in the first ten years of his life, constantly moving just as Great-Uncle Clintwood had to move and keep moving to avoid being arrested on false charges or be murdered outright.

This is not a glamorous story. It’s a painful, scary, shameful story, in which good men were replaced by bad men, honorable men replaced by crooks, and innocent people who were the victims of crime were portrayed as criminals — while the actual criminals sat at ease on the White House lawn. The Belchers have lived poor and they have lived rough, but through it all, they remembered who they are. They remembered their hereditary offices. They remembered their lineage. They never ceased the search to recover the Great Seals.

The Great Seals surfaced briefly in New York City in the possession of the Federal Reserve Board of Governors. They have now surfaced again in Indonesia. From our perspective, the Belchers are still the owners of the Seals no matter how many generations of pirates may possess them — under mandate and Maxim of Law: “Possession by pirates does not change ownership.”

Nor, obviously, do any documents that have been impressed with those seals since their theft during the first Roosevelt Administration have any validity or power to bind us, as they have been exercised without our knowledge or consent.

The custodians of the Great Seals in Indonesia are under demand to return them to us as stolen property. If these heirlooms are not returned, we shall have them re-cast in their original form.

It should be noted that the Office of **Hereditary Head of State** is not a Public Office. It is a **Private Trust Office**, a Lawful Person, and while **it is an Office which James Clinton Belcher claims by direct descent**,

the reason for doing so is to prove to the Queen that yes, we still exist.

It is not only those who received sovereignty at the hands of our ancestor: it is also those who received life from his body and soul who are still here on these shores.

There is no plausible excuse for the Queen or the Pope to continue their pillaging on our shores. Now, you are being called upon to remember who you are, too. Americans. Sovereigns in your own right. Not "United States Citizens" who are subjects of the British Queen. Not "Citizens of the United States" who are subjects of the **Roman Pontiff**.

The Federation of States dba The United States of America

There has always been a Federation running continuously through our history as a country from 1776 to today; it has been embodied by and carried forward by the individual people and their progeny who were involved in the Federation and its work from the start.

As an instrumentality of the States and the people of this country The Federation of States is the only such organization that survived the Civil War -- and it only did that by a hair's breadth. It very nearly died, both because of the dangers involved in continuing its operations and mission, and because of the time span involved.

Just a very few people-- less than 200-- carried the entire burden for decades. Most of them survived in remote locations and lived as migrant workers to avoid persecution by the Tory Corporations that usurped upon our lawful government.

They had to run in the dark and keep on the move, change their names, change their occupations, change their locations like criminals on the run. Having moved twelve times in the first ten years of his life and endured much humiliation and abuse; James had no chance of a normal life because of his family's unspoken obligation to keep the Federation of States alive.

Just as many people mistake a "church" for a building and not the body of people making up a church, they mistake our Federation and our American Government as a whole, as a thing apart from the body of people who have preserved it. It's not.

It is literally as even Abraham Lincoln admitted and described it, a government made of people, existing by the people's participation in it, and designed for the good of the people.

In the days to come, the people of this country will become educated again about their country and its cultural and philosophical foundations, its organization and institutions, its laws, and their heritage.

A full appreciation of The United States of America defined as an unincorporated Federation of States will be part of that education. For now, what is most important and what everyone needs to focus on, is understanding their own role, their own empowerment and limitations, and their own State Government.

The Federation spent twenty years locating and claiming back American assets that have been trafficked offshore "for safe-keeping" and used for the enrichment of foreign interests. We, Americans, have been the goats. It's our assets funding a large percentage of everything, but we have not been in possession

or control of our own assets and have largely not benefitted from our assets since the Civil War. We have had to do this alone, out of pocket. So far, it has been all outflow and has come out of our own pockets.

We have, however, found the missing assets; and we have staked the American claim for everyone; and we are progressing the claims.

The Federation will be working with other governments in international jurisdiction to clean up the environmental damage and health damage that has been inflicted worldwide. This will require a mammoth international effort over the course of decades, but new technologies will be unleashed. And somehow, with goodwill and some common sense, it will all get done.

The entire scenario that you have known in the past, with political piggies at the trough and lobbyists running to Washington to pad the pockets of their constituents, is about to go the way of the Dodo, so a lot of the assumptions that you are making about money and management of public money will no longer apply.

The people of each country will have a direct voice in how their money ---both public and private -- is spent, and won't, generally speaking, require a lot of "representation" or middlemen at any level of the government.

Fiduciary of The United States of America

How did Anna von Riezinger become Fiduciary?

By doing the work of the **Fiduciary Office**. She, as a Fiduciary, has very plainly stated functions, one of which is to protect and preserve the assets of all the States.

Nothing much more needs to be said. States Passed 2nd Public Law A1010124

2024

March 1, 2024 – States of the Union passed second [Public Law – A1010124](#): “All recoupmets and purloined property interests, meaning intellectual and performance property rights (**PKIs**) as well as physical assets, will be returned to the Office of our Fiduciary for restitution and auditing and return to the rightful owners on a worldwide basis. For the purposes of this Public Law, including the necessary **recoupmet** actions, we authorize the use of extra-territorial force and administrative support as needed.”

First Bilateral Trade and Commercial Bank

2023

2023 – First International Bilateral Trade and Commercial Bank of the American States Assemblies chartered May 28, 2021 opens to the public for the first phase of opening accounts – one side to deal in **lawful money** and the other side to deal in commercial paper. The American Council Team Established 2022

2022 – The American Council Team (**TACT**) was established by the Fiduciary to provide a resource with up-to-date information that is fact based, organized, and easily obtained. To assist the Assemblies to be fully functioning and to provide assistance for the Federation when needed. Focus on the Assembly **Reconstruction Process** and getting every State of the Union fully Standing: 4 pillars functioning, State of State reconstructed and the Assembly can demonstrate that they are capable of running the State.

2022 You Know Something Is Wrong When

Fiduciary Filed in International Court 2021

January 1, 2021 – States of the Union passed first [Public Law – A1010121](#): “no person or Person or PERSON of any kind shall in any respect claim to have any commercial or trade ownership interest in a living man or woman, baby, boy, or girl, by any means at all.” This law addresses the transhuman agenda afoot to edit or modify the genes of humans with mrna technology via air, water or injections and claim ownership of that body when this biologically engineered and patented substance is purportedly found existing in a body”.

Final Territorial State Enrolled Into The Union 2020

October 2020 – All territories that entered into territorial statehood from 1860-1959 provided by the Northwest Ordinance were **enrolled** into The Union of States under the **Equal Footing Doctrine**. The [Final Enrollment](#) of the **territorial states** was on October 19, 2020.

2020 Peacekeeping Task Force Chartered

Head of State Issues 1st Decree Over Mandate 2019

First Declaration as States of the Union 2017

October 21, 2017 – First Declaration as States of the Union, Newly Reconvened: [Declaration of Flag/Conveyance of Abeyance/End of Presumed Interregnum](#) and Proclamation in Addendum. Raised our **Civil Peace Flag**.

Issued Payment Bond to Redeem World 2017

January 6, 2017, Head and State and Fiduciary issues Payment Bond and lodged it with the Vatican Chancery Court, which is the bank for the Holy See, and redeemed all the Named and NAMED entities worldwide.

Private Estate Lien and Judgement 2016

July 4, 2016 – Head of State and Fiduciary records [Private Claim, Lien and Judgment Order](#): “The Vatican and its franchises must disgorge all the titles to American property which it has been holding under false pretenses and profiting from.”

Head of State Issued Sovereign Letters 2015

November 4, 2015 – Head of State contracted with the Native nations of the **Athabascans** and **Lakota Sioux** to become the new federal service providers and issued new **Sovereign Letters Patent** and **Joint Declaration of Sovereignty** with our new federal partners, upholding The Declaration of Independence and expanding it to include all people born on American soil are Americans.

Pope Francis Liquidates UNITED STATES, INC 2015

2015 – Pope Francis liquidates UNITED STATES, INC. Municipal corporation but only after they shuffled off the bulk of the assets to other incorporated entities owned and operated by the same shysters.

Final Judgement and Civil Orders 2014

February 3, 2014 – Fifty-five (55) days passed with no rebuttal to Fiduciary's Commercial Notice, under Law of the Sea the claims and demands presented by the [Final Judgement and Civil Orders](#) dated February 3, 2014 are decided and now in permanent settlement. They stand as fact in law.

Fiduciary Files UCC Liens and Makes Her Will 2011
