FALSE CLAIMS IN COMMERCE (language fraud)

Clearinghouse Receipt #1 (BERTH {birth} Certificate) (BC)

(BC2) transfers "cargo" from land to sea

TROVER & CONVERSION (of man and of things)

+/- 7 years later CLEARINGHOUSE RECEIPT #2 (BC2)

(BC2) says nothing about **man and estate** and is merely a transfer record only, so the B.C. and deposit records @ Chicago (G - of the 12 lettered banks) FED Bank record transfer of estate with name as "Authorized Representative" = unauthorized/undisclosed claim of ownership interest & continue to use estate as collateral backing their corporate debts

INFANTICIDE
Legal person #1 first middle Last intestate infant decedent estate (estate #1-private)

PERSONAGE
Legal person #2 First Middle Last British territorial citizen - 1st (BC)

PRESS-GANG + INDUCEMENT
Municipal PERSON FIRST MIDDLE LAST ESTATE TRUST (estate #2-public)

IDENTITY THEFT
citizen of the United States

HUMAN TRAFFICKING
GENOCIDE 18USC§1091
2nd (BC2) short form

registration is unlawful conversion of **man and estate**

ENTIRE justice system is human trafficking FOR PROFIT under corporate veils
