Mischaracterization of our native political status is a crime of state subject to capital punishment under international law, and is prohibited under both the Hague and Geneva Conventions.

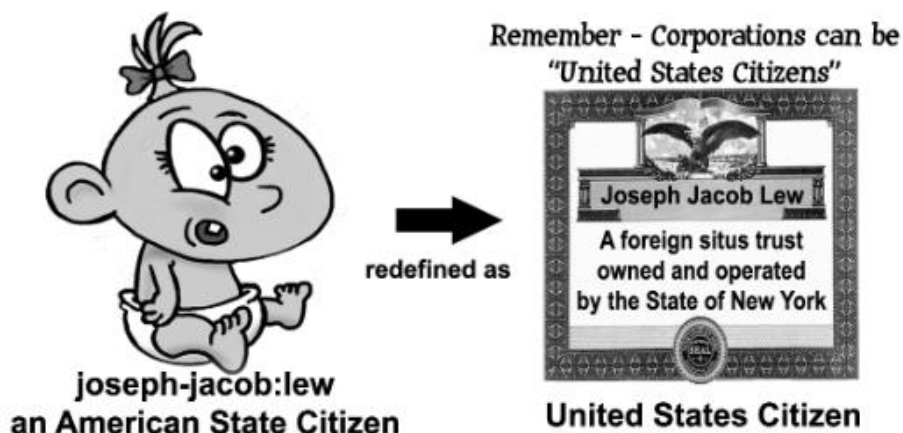
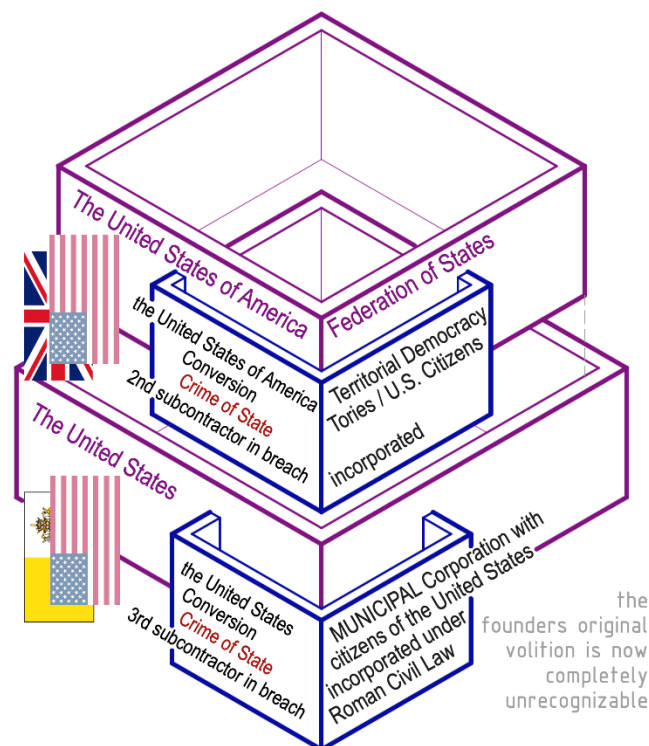
We, Americans, don't live in a democracy.

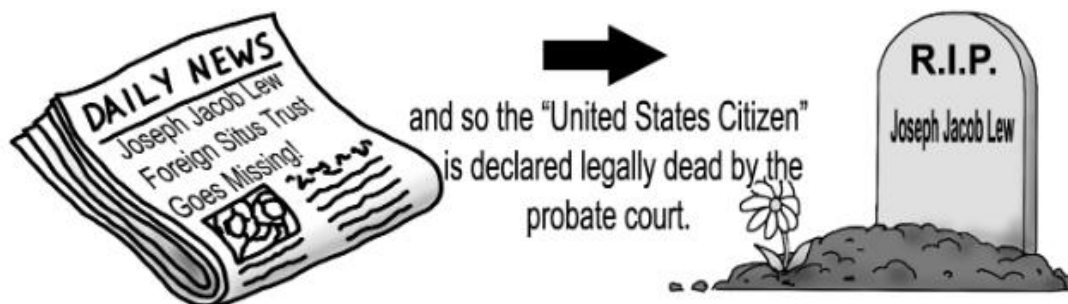
We, Americans, don't live in a theocracy.

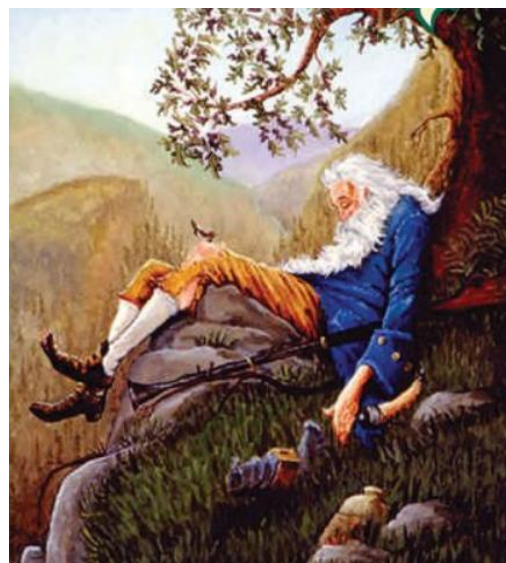
A general revaluation of currencies against the gold standard will be commencing at the public level to establish new commodity valuations and address the widespread rigging of the commodity markets worldwide.

The good news is that the States, which do have international powers, are already in the assembly process and making steam. As people join their State Assemblies, the County Assemblies are automatically being repopulated, too.

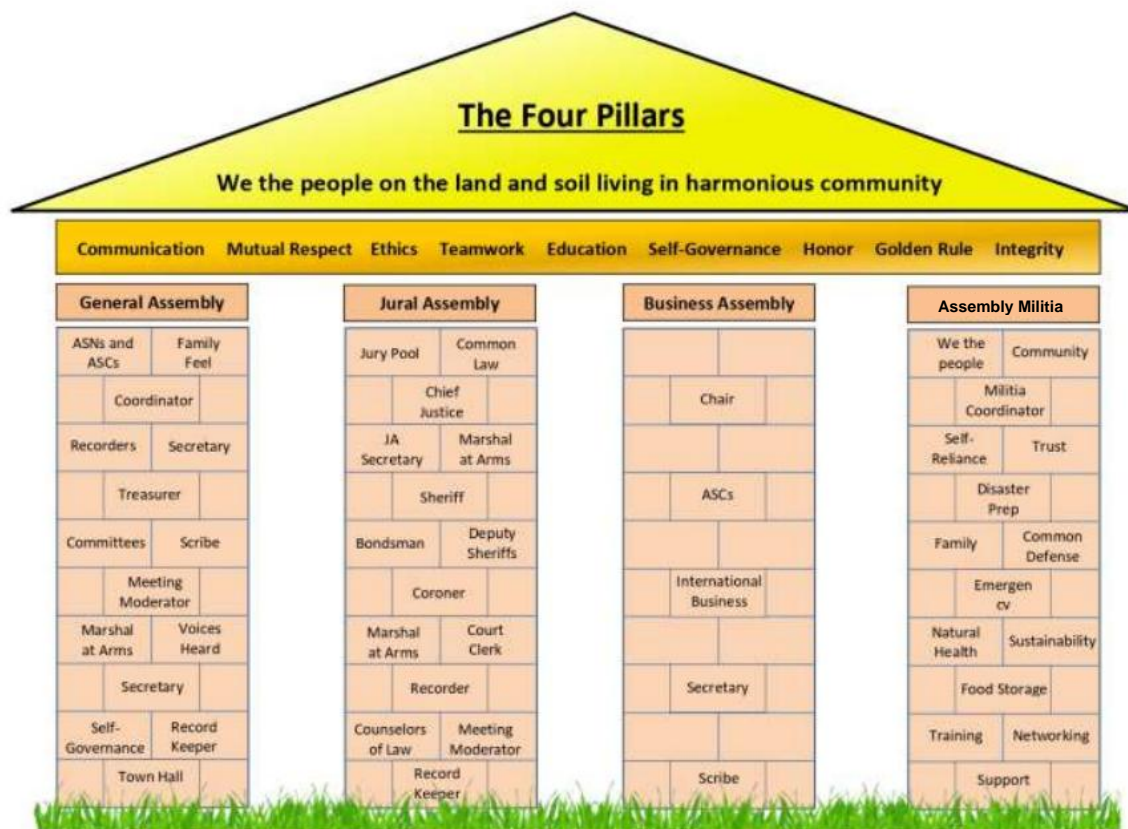

Join your State Assembly and help in the assembling of the 4 pillars of our American Government.

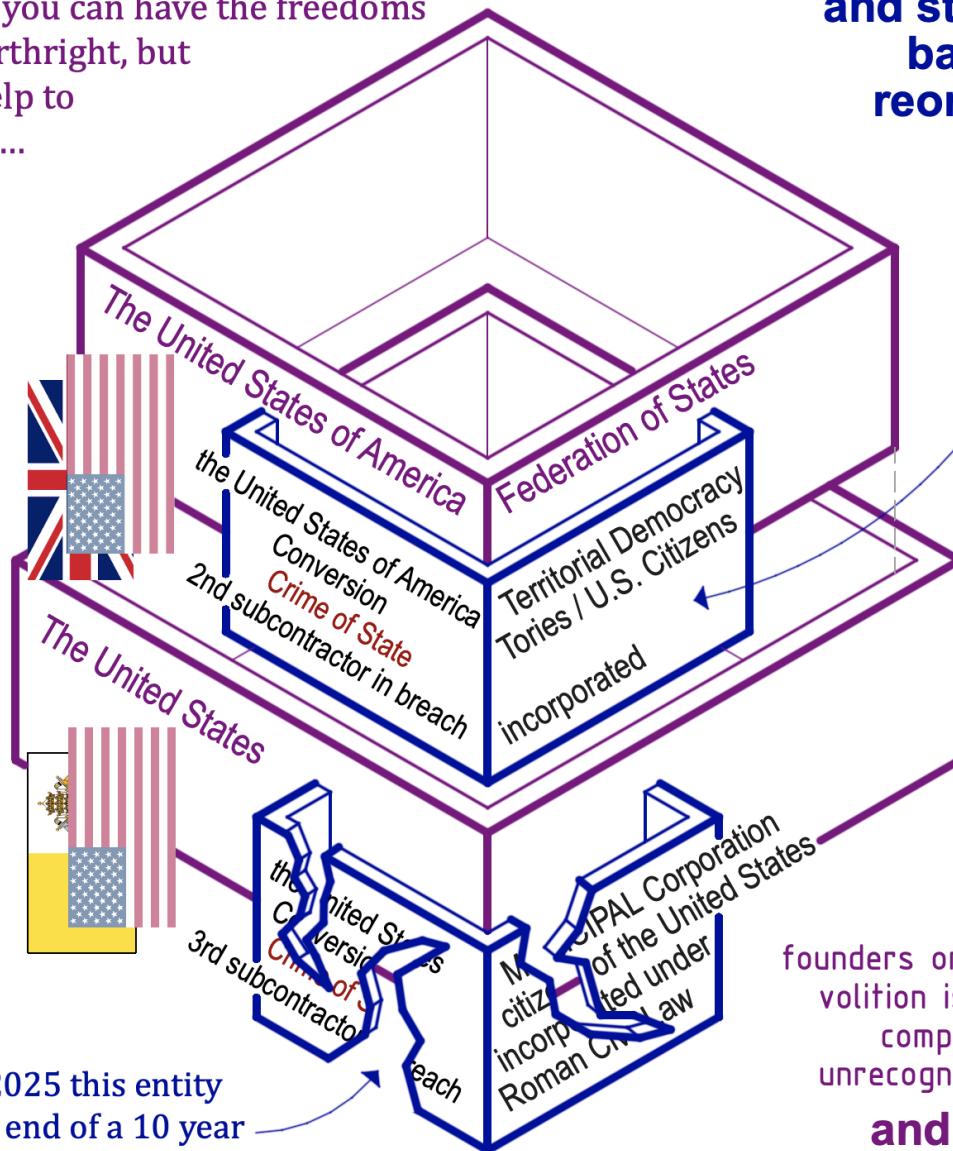




## Newsflash!
