Are you happy knowing that you are paying a mortgage that is in fact owed by the same State Trust as a result of State of State spending you were unaware of and never authorized?

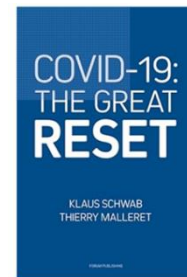

When your candidate doesn't win because your votes don't really count or because the ballot count was rigged, as it often is, when our popular vote varies too widely from the Electoral College vote, how do you feel? Still happy?

Do you realize that political parties are lobbyist groups, just like the Tobacco Lobby, and they pre-select the slate of candidates you have to choose from? So, these elections are already "rigged" in all these different ways?

The U.S. Government is a set of foreign, private, for-profit corporations headquartered in the District of Columbia -- put simply, USA, Inc. which is a British Crown entity and US, INC. which is a Municipal Corporation. They sucker you into becoming a "Voter" and shareholder, so they can go bankrupt and foist all their debts onto you.

These corporations can run their elections as they please. Every fight fought for a right to vote gave you the "right" to vote in the US government subcontractor's corporate elections, not the Public Elections you expect and are owed.

That you have been enslaved and defrauded by your own Federal Subcontractors, right here in America?

Ever wonder why you would need a license—which is permission to do something that is otherwise illegal --- to get married, practice law or medicine, drive your own car, or even cut hair?

- Are you happy with “registering” your newborn baby as chattel property belonging to the U.S. (British Territorial) Government Corporation, the USA, Inc., by signing that “routine” hospital paperwork?

Did you know that they listed you as an “Informant” – that is, someone who just found this criminally abandoned baby and turned it in to the Authorities? And then purportedly, you left the poor little tyke as a Ward of the State-of-State franchise corporation doing business as the State of Michigan, Inc. Or the State of New York, Inc. or the State of California, Inc.

And what does it mean when the State-of-State, like the State of Illinois, “securitizes” your baby’s living flesh as a chattel asset belonging to them? When they issue a bond on the projected value of his or her lifetime labor to cover their debts? Slave bonds, anyone?

That’s what all those Federal Reserve Notes are issued upon – the labor of indentured servants and slaves, securitized as assets belonging to living chattel.

That’s why we call Federal Reserve Notes “Blood Money” and that’s why they are totally illegal and immoral and why we should object to their use. Formally. In writing. The Great Reset or Fourth Industrial Revolution is nothing more than a rebranding of the same old criminal fraud that has been perpetrated on our shores for over a century and a half.

The list of adhesion contracts goes on and on. Adhesion contracts are unconscionable, unilateral contracts made by you that bears only one signature – yours. This entire process would violate your rights under the Bill of Rights to the Federal Constitutions, if you were "recognizable" as an American, but you see, you're not being recognized as an American. Thanks to your Mother signing an undisclosed contract in the hospital however many years ago, you have been misidentified as a British Territorial U.S. Citizen, as if you had been born in Puerto Rico. And Puerto Rico is a British Territorial United States Commonwealth. 2. The second step is to clearly and succinctly object to these practices and legal presumptions.
3. The third step may require us to engage in additional activities --- research, legal actions, political lobbying, media and educational programs, and soul-searching.

We have to discover how this great country, the Land of the Free, has been reduced to this condition. We have to accept our part of the blame, because obviously, we weren't minding our own store, weren't educating ourselves or our children about our actual government, weren't taking appropriate action to discipline our public employees, conduct actual elections, and otherwise tend to our own affairs.
