America's Civil Peace Flag

Attention, International Public Notice. This is not a solicitation. This is an approved lawful Notice from the American Government.

This International Public notice is to inform you that the foreign United States Government has criminally converted your political status from an American to that of a Foreign Citizen.

How and why?

What you are about to learn is the true American History that was removed from our public school system completely by 1974, and more history that has been hidden from you.

Know that it was all intentional.

Let's begin.

Your birthright as an American is to live in peace and abundance, which includes a public inheritance and a private inheritance.

We, Americans, are all "sovereigns in our own right" because of one man, "William Belcher."

William inherited sovereignty in his own right from William the Conqueror in 1087 AD, and you have inherited that same right from him. This special form of sovereignty attaches to everyone born on the land and soil of this country. Unknown to you, you have inherited both private and public sovereignty.

This fact brings us to our first American History lesson that was hidden from you.

"Sovereignty in your own right" grants absolute control over your own body and property, but nobody else's.

We fought and gained our public sovereignty as a country and nation when we won the Revolutionary War.

So, we are a sovereign country ruled over by sovereign people.

Many nations can occupy the same land and soil, and that is the situation here in America. A member of the Winnebago (Ho Chunka Nation) born in Black River Falls, Wisconsin, has an automatic Dual Nationality status as both a Winnebago and as a Wisconsinite.

They inherit their individual sovereignty from William Belcher, like any other American born on this land and soil as their birthright political status and they maintain their Winnebago identity as part of the Ho Chunka Nation too, being their cultural heritage.

The Colonists and some of the Native Nations fought together to gain America's independence from several tyrannical Kings. The last American War was the War of 1812, and we have not waged a war on anyone since then.

Native nations have been abused by the foreign United States Government, who are our Subcontractors, like all the rest of us. This is not the doing or fault of the actual State, Wisconsin, nor is it the fault of the Ho Chunka Nation either.

Many of the Eastern Seaboard Native nations, like the Lenape and the Delawares, had treaties with King George II prior to the revolution that were not honored. This is because King George lost the Revolutionary War and skipped town without mentioning that he owed them a settlement in gold for not being able to keep his treaty agreements.

The Western Native Nations, except in California, generally speaking, hadn't been involved in much contact or conflict with the colonists or the kings prior to the so-called "Civil War," (*more on the "Civil War" later.*)

Unfortunately, the so-called "Civil War" began the era when the British Territorial U.S. Army, operating as the "bluecoats," caused so much devastation and it led to the creation of the Reservation System.

Everyone concerned was violently defrauded, first by the King avoiding his treaty obligations to the Eastern Native Nations, and later by the British Territorial U.S. Army running rampant over the Western Native Nations.

You can see why they wanted to keep this little piece of American History out of our school textbooks.

I'm about to tell you some more hidden American History, and yeah, you best believe it was hidden on-purpose too.

Each one of us is owed money and prepaid credit we and our ancestors earned, but were never credited for and never paid.

This money is coming back to us, because we and our parents and grandparents have been charged taxes, mortgages, et cetera, that we never owed, and because the fiat money system was mismanaged in a way that has resulted in a large excess of prepaid credit being owed back to each one of us. That money and credit needs to be returned to you.

In addition, there are giant family trusts like the "D'Avila Family Estate and Trust" that's worth over "THREE HUNDRED DODECALLION" - \$300,000,000,000,000,000,000,000,000,000,000,000.00 alone, along with the St. Germain Family Trust, the B.K. Durham Trust, plus over 5,000 more, which were largely gifted to all peoples of the world.

For example, the D'Avila funds are a bequest for a specific purpose: "to break the chains of poverty and ignorance." This goal has been the same since 1520 A.D., but dishonest Trustees and wars and other things have prevented deployment of the funds for the specific purpose.

The Avila Family Trust indenture hasn't been honored in over 500 years. It's time.

These are the public and private inheritances that you don't know you have.

Why were you not told?

A 160-year-old criminal fraud scheme against you is still in progress... and that's why most of you don't know this. The criminal bankers who didn't return your money and credit, in collusion with the foreign United States Government, are both standing in the way of these family trust funds being deployed worldwide.

Americans don't live under a Constitution as Citizens.

We live by the Declaration of Independence as sovereigns. You probably were not taught this American history, were you?

Other words for citizen are employee, officer, subject, slave and indentured servant. You were born a free man or woman with unalienable rights, but you were made into a bonded servant, then later into a slave by two birth registrations.

The U.S. Governmental Services Corporations – acting in breach of their contracts – created those bonds. “What contracts?” you may ask. You probably know of two such contracts, “The Constitution of the United States of America” and “The Constitution of the United States.”

That's right.

These Constitutions are contracts that we have with two corporations. The USA Inc. works for us and the U.S. Inc. works for us. The United States Governmental Services Corporations are our Subcontractors, and We, Americans, and our American Government are literally their employers.

All this time, you thought they worked for you because you paid Taxes. Nope, that's not the truth of the matter at all.

Here's another important, little-known fact in American history.

Those D’Avila Trust Funds I told you about... they fully funded Government services for everybody. No more taxation was required or even needed for public services since 1941. All taxes since then went toward war reparations and as gifts to the British Monarch and to the Pope, which they extorted as gift and estate taxes that you never owed.

World War II forced the world to rebuild. So instead of relieving you from taxes, the Avila Funds were diverted into the Marshall Plan and other efforts. These funds were loaned out for this purpose for 50 years and were supposed to have been repaid in 1995.

But the due date came and went.

The banks asked for and were granted a 10-year extension with settlement due in 2005.

But again, that date came and went too.

We began hearing rumors in 2022 about “global project funding” from the U.S. military. They didn't tell you that this is where that funding was coming from and that they were robbing the heir of the trust and ignoring the trust indenture --- AGAIN!

The funds are not coming from the World Bank, not the Global Debt Facility, not any “Global Collateral Accounts,” not from NESARA or GESARA, not from the World Trust --- which was set up and provided by the family of our fiduciary for The United States of America Unincorporated --- and they have bungled that beyond belief too.

This is the U.S. military's way of *sneaking-in-the-back-door, don't-let-them-know-I-stole-it-in-the-first-place*, criminal attempt to put the money back.

Yet, they still continue to exercise non-consensual control over funds that don't belong to them.

We told them, “No!” Nowhere, in your service contracts are you granted Fiduciary authority to access any funds on our behalf.

You also most likely don't know that they, acting in continual Breach of Contract, have authorized other criminal and fraudulent “legal” activities too.

Oh, did you just “think” to yourself – “How can it be both criminal, yet legal, at the same time?”

Yes, I thought so.

Let me just identify a few of those criminal yet “legal,” activities to help you better comprehend what they are doing.

Number one, when you make a “bank deposit,” you think you are putting your money in the bank for safekeeping. But No... You are “legally,” although unknowingly, giving your money to the bank for “safehaving.”

Did you know that?

Your money is now theirs every time you make a “bank” deposit. They can now “legally” use it for all of their so-called “lending” that they claim to be doing with “their” money.

This is what you call semantic deceit. It's the name of their game and it's legal.

Not to mention that those federal reserve notes are not even “money” at all. Yeah, that's number two. Another criminal yet “legalized” racket they authorized.

A Federal Reserve Note is a promissory note, that is an I.O.U. --- and because there is no due date and no specific form of repayments dated on it, it's not a "negotiable instrument" at all.

Yet, you have been forced to use it as money in exchange for goods and services.

Now class, can anyone give me the definition for inflation?

Number three, our honorable American soldiery were turned into a paid foreign mercenary force. The War of 1812 was the last legitimately declared war.

All wars following that, including the so-called "Civil War," were and are not properly declared wars, just part of a saga of continual mercenary conflicts, i.e. wars-for-profit.

Did I mean to say that the U.S. military is both criminal and legal? Yes. I did.

Wars-for-profit, i.e. mercenary conflicts, are when Presidents or CEOs of commercial corporations, like the United States of America, Incorporated, hire trained soldiers to steal, kill, and maim as they devastate communities and economies for commercial gain.

Tell me... what did those ancient artifacts you were ordered to confiscate on your first missions in the Iraqi War have to do with protecting America's freedom?

Soldiers, please read some real American History to learn what wars-for-profit are really about. That includes all wars since 1815. And remember these flags... both the Civil Flag and the Title IV Military Flag belong to us too.



Here's another example of more Subcontractor abuse of delegated powers. We did not authorize them to instigate commercial conflicts, i.e. “wars-for-profit” all across the globe in “Our” name.

You see, there is a lot of hidden-on-purpose American History removed from our public schools and textbooks to make you wonder, Why?

There was a third constitution that we hear nothing about.

Our American Government contracted with one American subcontractor and two foreign subcontractors, the British Monarch and the Roman Papacy – done under three separate constitutions.

The American contract is called “The Constitution for the United, lowercase U, States of America” of 1787. It delegated limited authority to the American Federal governmental services provider as a Federal Republic. The British contract is called “The Constitution of the United, capital U, States of America” of 1789. It delegated limited authority to the British Territorial governmental services provider as a Territorial Democracy. The Roman contract is called “The Constitution of the United States” of 1790. It delegated limited authority to the Roman Municipal governmental services provider as a Municipal Theocracy.

Let me say it another way.

Replace the word “Constitution” with the word “Contract,” then read it like this.

“The Contract for the United States of America” of 1787.

“The Contract of the United States of America” of 1789.

“The Contract of the United States” of 1790.

Do you comprehend the truth now?

The “Constitutions” are nothing more than service contracts to work for us.

The for-hire military, the Federal Civil Service, and the whole, Federal hierarchy are supposed to be here to provide us with 19 enumerated services as defined in those Contracts. That's why we delegated “enumerated powers” to provide those services.

However, it seems that they don't read very well because they have criminally breached, violated, and unilaterally added to the terms of our agreement.

As their employer, how would you rate their performance card? A Big Fat F minus!

We started out with three, but only our foreign federal subcontractors remained in operation after 1861.

Why did only they remain?

Because they got rid of the "competition."
